GENERAL: FREEWAY is a non-ionic, organofunctional silicone surfactant. FREEWAY will decrease surface tension of spray solution below conventional surfactants resulting in better coverage. FREEWAY promotes rapid spreading at low use rates. High water volumes can result in excessive run-off of spray. Adjust rates of FREEWAY or spray volume to get coverage without run-off.

MIXING: Fill spray tank half full with water and begin agitation. FREEWAY is a low foam formula but some foam may be generated during mixing. If foaming is anticipated or experienced add an anti-foaming agent like UNFOAMER® to tank before adding pesticides. Add pesticides / foliar nutrients as directed by label while maintaining agitation. After pesticides and foliar nutrients are thoroughly mixed, add desired amount of FREEWAY. Some pesticides have stated adjuvant use rates. In all cases, the pesticide manufacturer's label should be consulted regarding specific adjuvant use recommendations and that rate followed. Do not add adjuvant at a level that would exceed 5% of the finished spray volume. For tank mix compatibility concerns, conduct a jar test of the proposed mixture to ensure compatibility of all components. Mix components in the same ratio as the proposed tank mix.

DIRECTIONS FOR USE: Lower spray volume generally require high rates for best results.

Basal Bark Treatment: FREEWAY is specially designed to aid penetration of fertilizers, nutrients, insecticides, fungicides, and herbicides through the bark. Use 1% to 2 1/2% FREEWAY by volume of spray solution.

rinse (or equivalent) adding rinse water to spray tank. Offer container for recycling or dispose of container in sanitary landfill, or by other procedures approved by appropriate authorities.
