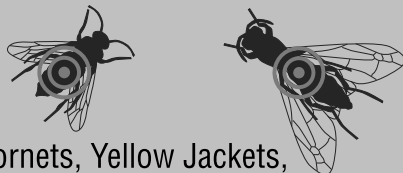

**FOR USE AROUND:** Residential, Commercial and Institutional Establishments. Excellent for use around sensitive facilities such as Schools, Government Buildings, Nursing and Assisted Living Facilities, Office Buildings.

**FOR USE ON:** Wasps, Hornets, Yellow Jackets, and Spiders.

#### DIRECTIONS FOR USE:

READ ENTIRE LABEL. USE IN ACCORDANCE TO LABEL INSTRUCTIONS.

**FOR OUTDOOR USE ONLY. SHAKE WELL BEFORE USING.**

This product works on contact and is non-residual. Contact as many insects as possible.

**Wasp and Hornet Treatment:** Stand a safe distance from the nest. Hold canister in an upright position and aim actuator opening toward nest. Treat nest until wet. Contact as many wasps/hornets as possible. Best time to treat is in the evening or early morning when they tend to be in or around the nest. Repeat as necessary.

**Yellow Jacket Treatment:** Stand a safe distance from the nest. Hold canister in an upright position and aim actuator opening toward nest. Apply with a sweeping motion and contact as many yellow jackets as possible around nest opening. Next, approach nest opening and apply directly into opening for 8 seconds to kill yellow jackets in the nest. This will also repel any yellow jackets trying to return to the nest, and cause them to fly away. Repeat as necessary.

**Spider Treatment:** Aim actuator at spiders and web and apply until wet. Contact as many spiders as possible. Repeat as necessary.

#### Precautionary Statements:

**Caution: Avoid contact with eyes and skin.**

#### FIRST AID:

**EYES:** Flush with water for at least 15 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a physician if irritation persists.


**SKIN:** Wash exposed area with soap and water thoroughly. Remove contaminated clothing. Get medical attention if irritation persists.

**INHALATION:** Remove person to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.
